### **RECTIFICATION OF THE AMOUNT PER SHARE OF INTEREST ON EQUITY**

TIM S.A. ("TIM" or "Company") (B3: TIMS3; NYSE: TIMB) informs its shareholders and the market in general that due to the change in the number of treasury shares in the period prior to September 26, 2025, there was a change in the gross amount per share announced in the notice to shareholders of September 23, 2025, as shown in the table below:

The gross amount per total share was increased by R\$ 0.0000558313 in view of the increase in the number of treasury shares and, consequently, the decrease in the number of shares entitled to receive dividends.

The payment will take place until January 21, 2026 in the amount of R\$480,000,000.00 (four hundred and eighty million reais), without the application of any monetary adjustment index, with the date of September 26, 2025 being the date that will serve to identify the shareholders entitled to receive such amounts. Thus, the shares acquired after that date will be *ex-right* to distribute interest on equity.
